1. PURPOSE

- 1.1. The purpose of this document is to provide a procedure for the election of Student and Staff Representatives on the following Boards or Councils:
 - 1. The Board of Governors (BOG)
 - 2. The Vocational and Professional Council (VPC)
 - 3. The Board of Studies (BOS)
 - 4. The Student Council (SC)
- 1.2. The MCAST Act of 2023 stipulates that Student and Staff representatives are to be elected by and from Students and Staff respectively. Moreover, Student representatives are also elected for the Student Council. These are distributed as follows:



	Student Council	13	Thirteen Students selected from amongst the College's registered students

2. SCOPE

2.1. This procedure applies to all MCAST Staff and Students.

3. ELIGIBILITY

3.1. All full-time staff and students in all Institutes, Centres, and at the Gozo Campus, are entitled to cast their vote as part of elections for specific representatives (refer to 1.2 above)



4. DATES AND DURATION OF ELECTIONS

4.1. Elections will be held online on dates established by the MCAST Electoral Commission from 0800 until 2000 hours.

5. ADMINISTRATION OF ELECTIONS

- 5.1. All elections (i.e. both Staff and Student elections) will be coordinated and overseen by the Appointed Electoral Commission.
- 5.2. The Electoral Commission is appointed by the MCAST Principal and CEO.

6. NUMBER OF ELECTED REPRESENTATIVES

6.1. Kindly refer to the table in 1.2 (above) for the number of representatives to be elected from each election

7. ELECTIONS PROCEDURE

- 7.1. All elections shall be held online.
- 7.2. The list of eligible candidates will be made available to the electorate via Internal Circular, prior to the election date. Reminders may be issued as necessary.
- 7.3. The electorate will be informed via Internal Circular of the voting window timeframe/s.
- 7.4. Votes are to be cast via Microsoft Forms on dates as established by the electoral committee. No votes will be accepted beyond the pre-established timeframes.
- 7.5. Votes are to be cast using the personal MCAST email addresses issued to students and staff.
- 7.6. The voting process shall be anonymous.

8. COMMUNICATION OF RESULTS

- 8.1. Communication of results for each individual election, will be done via Internal Circular issued by email following the date of the specific election.
- 8.2. Results will be issued by the Electoral Commission.
- 8.3. At the end of the election process, once all elections have taken place, a final report with the result of each election, including any vacant spots, will be issued.
- 8.4. As per the MCAST ACT of 2023, Student representatives elected in any of the elections will serve a one (1)-year term, starting from the 1 December until the 30 November of the following year, provided that, they may be re-elected. Academic and Administrative Staff representatives shall hold office for a period of three (3) years, provided that, they may be re-elected.
