1. PURPOSE OF DOCUMENT

The purpose of this document is to define the regulations for the: Overall Classification, the Certification and the Individual Grading of Units for MCAST Undergraduate Degree and Master Degree Programmes.

2. SCOPE

This document is applicable to all MQF Level 6 and MQF Level 7 programmes at MCAST.

3. MQF EQF LEVELS 1 – 6

The following regulations apply to all programmes at Levels spanning from Introductory Level A&B to Level 6 delivered either at Full time or Part time.

3.1. Grading of Individual Unit Marks

- 3.1.1. The total mark for each unit is calculated by summing up all the marks obtained in (all) the assessments for the respective unit.
- 3.1.2. The total mark of the respective unit is then graded as per table below:

3.2. Overall Classification Process

- a. The total mark for the programme is calculated by summing up all the marks obtained in (all) the respective Units comprising the qualification.
- b. The final percentage mark achieved by the student for the programme of study is worked out by calculating the overall average mark achieved in all the units of the programme of study according to the pro-rata weighting of the units according to the number of ECTS of the respective units.
- c. For a student to successfully complete the programme of study and hence be eligible for certification, the minimum overall mark that needs to be achieved is 50% for each unit within the programme of study, excluding the unit of study that is awarded a Compensatory Pass (refer to paragraph 12.2)
- d. Candidates who successfully complete the full requirements of a programme of study will be entitled to claim the certification.
- e. Assessment grades/marks obtained from accredited external institutions by students who participate in exchange programmes (such as ERASMUS; etc.) shall be included in the students' transcript showing that the grades/marks were obtained in transfer. Any such units will, therefore, not be considered in the overall classification of the qualification. In such cases, when working out the classification of a student, the formula used to determine classification shall be amended to take account of the 'missing' marks as fairly as possible. This is done in the best interest of the student in order to avoid positive or negative discrimination which can possibly arise due to varying marking practices
- f. Candidates who fail to complete the full requirements of a programme of study shall be issued a transcript of their academic record.

3.3. Overall Classification of Undergraduate Degrees (MQF/EQF Level 6)

- a. For the purpose of final classification, the results of all three or four years of study contribute to the final classification of the programme.
- b. A unit of 6 ECTS is assigned a maximum of 100 marks. The maximum number of marks for units with other workloads (e.g. 3 ECTS, 9ECTS etc.) is calculated pro-rata.
- c. For Bachelor Degree programmes, the assigned marks of the Units in the final year(s) are multiplied by 1.5 times as explained below:

Duration of Programme	Total ECTS	Years for which total of assigned marks is multiplied by 1.5
3 years	180 ECTS	3 rd year
4 years	240 ECTS	3 rd and 4 th year

- d. Grades/marks for each unit are added towards the final value (total points)
- e. The indicative overall classification boundaries are:



First Class	80% or higher
Second Upper	70% to 79%
Second Lower	60% to 69%
Third Class	50% to 59%

f. The overall classification boundaries can be moderated by the respective Degree Ratification Board depending on the overall performance of the cohort.

3.4. Programme duration, suspension of the programme and mapping of units (RPL)

The qualifications at MQF Level 6 are to be completed within a maximum specific number of years. Exceptions are allowed subject to a formal, approved request. Students who exceed the programme window can apply for an RPL process to complete the qualification.

3.5. Unsuccessful submission of the Dissertation

Students that fail their dissertation shall be provided with a number of options to remedy their situation, following a decision by the MCAST Degree Ratification Board as per DOC 100 para 3.1.5.

4. MQF/EQF LEVEL 7

4.1. MQF/EQF Level 7 Qualifications (60 ECTS taught units + 30 ECTS dissertation unit)

4.1.1. Grading of Individual Unit Marks

In the case of EQF / MQF Level 7 qualifications units are graded as 'Pass', 'Merit' and 'Distinction' as per the following grading boundaries:

- a. The total mark for the programme is calculated by summing up all the marks obtained in (all) the respective Units comprising the qualification.
- b. The final percentage mark achieved by the Student for the programme of study is worked out by calculating the overall average mark achieved in all the units of the programme of study according to the pro-rata weighting of the units according to the number of ECTS of the respective units.
- c. For a Student to successfully complete the programme of study and hence be eligible for certification, the minimum overall mark that needs to be achieved is 50% for each unit within the programme of study, excluding the unit of study that is awarded a Compensatory Pass (refer to paragraph 12.2 in DOC 005 Programme Regulations (MQF EQF Levels 5 7)
- d. Candidates who successfully complete the full requirements of a programme of study will be entitled to claim the certification.
- e. Assessment grades/marks obtained from external accredited institutions by students who participate in exchange programmes (such as ERASMUS; etc.) shall be included in the Student's transcript showing that the grades/marks were obtained in transfer. Any such units will, therefore, not be considered in the overall classification of the qualification. In such cases, when working out the classification of a student, the formula used to determine classification shall be amended to take account of the 'missing' marks as fairly as possible. This is done in the best interest of the student in order to avoid positive or negative discrimination which can possibly arise due to varying marking practices
- f. The marks of units achieved via APL, RPL, RPCL or RPEL shall not be included in the total for overall classification purposes (where this is required). Such units will be identified in the transcript and annotated accordingly. g. Candidates who fail to complete the full requirements of a programme of study shall be issued a transcript of their academic record.

4.1.2. Overall Grading

a. The ratification of the overall grading of EQF/MQF Level 7 Qualifications (60 ECTS taught units + 30 ECTS dissertation) programmes, falls under the remit of the Degree Ratification Board.

b. Master's Programmes are graded overall as 'Pass', 'Merit' and 'Distinction' and have the following boundaries:

4.1.3. Programme duration, suspension of the programme and mapping of units (RPL)

The MQF Level 7 programmes (60 ECTS taught units + 30 ECTS dissertation_) are to be completed within a maximum specific number of years. Exceptions are allowed subject to a formal, approved request. Students who exceed the programme window can apply for an RPL process to complete the qualification.

4.1.4. Failed or Not-Submitted Dissertation

Students who fail their dissertation shall be provided with a number of options to remedy their situation, following a decision by the MCAST Degree Ratification Board as per DOC 100 para 3.1.5. Students may also be offered the option to exit the Programme at PG Dip (without classification). If the student agrees, students will be asked to:

- submit a formal Resignation letter Form (referenced below), and;
- sign the form referenced below to confirm agreement.

4.2.2. Overall Grading Process

For a student to successfully complete the programme of study and hence be eligible for certification, the minimum overall mark that needs to be achieved is 50% for each unit within the programme of study, excluding the unit of study that is awarded a Compensatory Pass (refer to paragraph 12.2)
- c. Candidates who successfully complete the full requirements of a programme of study will be entitled to claim the certification.
- d. Assessment grades/marks obtained from external accredited institutions by students who participate in exchange programmes (such as ERASMUS; etc.) shall be included in the student's transcript showing that the grades/marks were obtained in transfer.
- e. The marks of units achieved via APL, RPL, RPCL or RPEL shall not be included in the total for overall classification purposes (where this is required). Such units will be identified in the transcript and annotated accordingly. - f. Candidates who fail to complete the full requirements of a programme of study shall be issued a transcript of their academic record.
- g. The ratification of the overall classification of Master by Research programmes falls under the remit of the Viva Committee. Details on the composition of the Viva Committee and the Viva sessions are available in the document referenced below.

h. The Overall Grading of Pass, Merit and Distinction, is based solely on the Dissertation Unit

4.2.3. Programme duration, suspension of the programme and mapping of units (RPL)

The Master by Research Programme (2 taught units of 6 ECTS each + 78 ECTS dissertation unit) are to be completed within a maximum specific number of years. Exceptions are allowed subject to a formal, approved request. Students who exceed the programme window can apply for an RPL process to complete the qualification.

4.2.4. Failed or Not Submitted Dissertation

Students who fail or do not submit their dissertation will not be awarded the degree as per DOC 237 para 6.3 (d).

4.2.5. Post Viva Request for Amendments

Students, who fail to fully satisfy the examiners at the first examination, following the Viva process, may be asked to effect minor or major amendments to their dissertations. In such cases, students can submit amendments for minor and major amendments only once.

The summative and written feedback will be provided in the form of an outcome letter collated by the Viva Chairperson (through the use of DOC 137 referenced below) and communicated by the MRes convenor.

The student shall be required to submit the amendments for re-examination and approval within a specified period of time. Students who fail to submit their dissertation amendments within the stipulated timeframe shall be considered as not completing the programme.

4.3. MQF/EQF Level 7 Master in Research Methods Programme - with 3 exit points (30ECTS + 30ECTS)

4.3.1. Programme Structure

Master in Research Methods is comprised of 90 ECTS which is divided as follows:

- PgCert Research Methods (30 ECTS)
- PgDip Research Methods (30 ECTS)
- Master in Research Methods (30 ECTS)

- 3. Master in Research Methods Comprising of 6 Units: All PG CERT and PG DIP Units plus an additional 30 ECTS Unit marked in Percentage Mark.

4.3.3. Overall Grading Process

- a. The total mark for the programme is calculated by summing up all the marks obtained in all the units marked in a Percentage mark. The unit which is marked via a Pass/Fail is excluded from the Overall grading Process.
- b. The final percentage mark achieved by the Student for the programme of study is worked out by calculating the overall average mark achieved in all the units of the programme of study (which are marked via a Percentage Mark) according to the pro-rata weighting of the units according to the number of ECTS of the respective units.
- c. For a Student to successfully complete the programme of study and hence be eligible for certification, the minimum overall mark that needs to be achieved is 50% for each unit within the programme of study, excluding the unit of study that is awarded a Compensatory Pass (refer to paragraph 12.2 in DOC 005 Programme Regulations (MQF EQF Levels 5 7).
- d. Candidates who successfully complete the full requirements of a programme of study will be entitled to claim the certification.
- e. Assessment grades/marks obtained from external accredited institutions by students who participate in exchange programmes (such as ERASMUS; etc.) shall be included in the Student's transcript showing that the grades/marks were obtained in transfer. Any such units will, therefore, not be considered in the overall classification of the qualification. The Master in Research Methods is to be completed within a maximum specific number of years. Exceptions are allowed subject to a formal, approved request. Students who exceed the programme window can apply for an RPL process to complete the qualification. (Refer to Doc 005 para 12.5 Programme <u>Duration for further details</u>).
